Change #3, Non-Smoking By-law passed with 70.63 yes votes

Change #4, Insurance Requirement (HO6 policy) passed with 70.65% yes votes

6. Board Reports

- a. **Auditor-** Matt Haugen of Riley, Penner & Benton, LLP reported on the Audited Financial Statements which had been previously provided to the members.
- b. **Treasurer** Sara Thompson reported that for the year ending July 31, 2024 total revenues were \$2,111,398, total operating, administrative, maintenance, and repair expenses were \$1,653,642 leaving \$457,756 of revenues over expenses. Mike Steinle made a motion to accept the Treasurer's report and it was approved unanimously.
- c. **President Update-** President Keith Lester spoke on the urgency to keep Regency House a safe place. Several recent attempts to enter the garage resulted in no losses. Owners must abide by the Regency House Rules rules that are in place to minimize unauthorized entries and thefts. If residents of Regency House are aware of any suspicious activities, they should contact the front desk attendant or immediately call the police
